Dear valued customer.

Dry Creek Landfill only accepts waste — certain very specific types of waste — from credit customers. The types of materials accepted at Dry Creek include:

• **Demolition Waste.** This includes roofing, wallboard, lumber, concrete, etc. will only be accepted in vehicles carrying 10 yards or more. Smaller loads of concrete, wire, rebar and stumps will be accepted on a pre-approved basis. Please call ahead if you have any questions.

Demolition waste is charged a rate of \$65.50 per ton at the landfill, with a minimum charge of \$340. All construction demolition MUST have an Asbestos Survey on file in our office PRIOR to disposal.

Trucks with significant quantities of general garbage or garbage mixed with demolition debris will NOT be accepted at the landfill and will be redirected to the Transfer Station at 8001 Table Rock Road in White City. The fees at the Transfer Station are based on yardage, NOT on weight, and will be charged at the rate of \$17.80 per yard for loose demolition waste and \$41.60 per yard for compacted demolition waste — with a minimum charge of \$26.70.

- Clean Soil. Must be a minimum of 10 yards. Contact Jenifer Stuber for approval at 541-494-5455.
- Contaminated Soil. Requires a pre-approved permit. Contact us at 541-779-4161.
- Materials Containing Asbestos. Only allowed on Wednesdays by appointment. Call 541-494-5491 at least 24 hours in advance for an appointment. Requires a completed DEQ Asbestos Waste Shipment Report Form ASN4. Call us at 541-779-4161 for a permit form. Asbestos is charged at a rate of \$89.20 per cubic yard and prepaid bags at \$20.90.
- Animal Mortality. Accepted at the Dry Creek Landfill Monday through Saturday from 7:30 am to 4:30 pm. Requires prior two-hour notification. Call 541-494-5491.

Disposal fee is as follows: \$50.70/first large animal and \$25.30/each additional large animal \$25.30/first small animal and \$12.70/each additional small animal

• Other Waste. Other approved waste may be accepted. The type and pricing for such waste will be as set forth on a separate pricing sheet.

Please note that all rates are subject to change.

Vehicle Requirements

All vehicles or trailers hauling any of the above materials must be self-dumping. This includes tilt bed, dump bed and so on. Tractor trailers transporting municipal solid waste will be unloaded utilizing a "tipper." All drivers must follow all instructions of landfill personnel. Dry Creek Landfill is not responsible for any damage caused by the use of the tippers. Drivers recognize that there may be loose waste materials on the access roads or the face of the landfill, and Dry Creek Landfill is not responsible to any damage to any truck, trailer or other vehicle while driving to or on the face of the landfill or otherwise on landfill property.

Covenants, Warranties, Indemnities, Venue, Legal Fees

You agree that you will only deliver the specified and approved waste ("Approved Waste") to Dry Creek Landfill (and if applicable Rogue Transfer & Recycling), and will indemnify and hold Dry Creek Landfill, Rogue Transfer & Recycling (if applicable) and their affiliates harmless for any losses, liabilities (including fines and legal fees and cost of remediation or removal) relating to non-Approved waste, including without limitation any hazardous waste. In the event of any legal action relating to the disposal of waste at Dry Creek Landfill or Rogue Transfer & Recycling, you agree to the exclusive jurisdiction and venue to courts in Jackson County, Oregon. You agree to reimburse Dry Creek Landfill (or Rogue Transfer & Recycling) for any costs (including legal expenses and costs) relating to collection of any amounts owed to Dry Creek Landfill, Rogue Transfer & Recycling (if applicable) or their affiliates in connection with disposal of waste at Dry Creek Landfill and, if applicable, Rogue Transfer & Recycling.
